1.i. The Minutes of the meeting held on 30th May were agreed and signed,

2 i. Clerks Report

i.Beaford Centre Field next to Village Hall, the field has been cut and is to be cut again, it was suggested an invoice should be put in to cover costs. The DAAT site needs to be pegged out. ii. Parish Council Notice Board, the board has been made, the metal has been delivered erection is imminent.

3. Chairman's Report.

i. Grant applications for the play equipment, Councillors are applying for grants. Well done to Cllr Underhill, Cllr Huxtable and Cllr Pearce for their efforts so far applications have been submitted. The Viridor result is imminent.

It was proposed by Cllr Huxtable seconded by Cllr Rintoul to go ahead and purchase the two swings three quotes have been received and it was agreed to go with Rhino at a cost of £4000 plus VAT all in favour, so the order will be placed.

Cllr Huxtable is to purchase a flat swing, all in agreement.

Also, the hill with the drainpipe in it is to be is to be investigated, quotes are to be sought for the pipes and Cllr Huxtable is to ask Mr D Rodgers to quote for the work, the site will be where the willow was as that is a low site and needs building up, all in agreement.

4. Highway Issues,

i. Signs, signs were asked for on the access roads towards Marshalls Mead "Children at Play" these have been ordered from Blueorange.

5. County and District Councillors items, Cllr Saywell was unable to attend the meeting but forwarded notification from DCC who are proposing to close the A3124 for up to two months from the middle of September. This is due to a length of embankment/drystone retaining wall on the A3124 just east of RHS Rosemoor Gardens that is showing signs of deterioration and has caused cracking in the carriageway. The section of cracking also has no support in the form of a retaining wall, which is also the reason for this scheme. Cllr Saywell hastens to add this is *not* for the sections of the A3124 that were recently resurfaced.

Obviously, this is going to have a major impact on Beaford, other close parishes as well as RHS Rosemoor.

To that end Cllr Saywell has organised a meeting to discuss the closure with the Highways Engineers, the Neighbourhood Highways Officer, the site manager at RHS Rosemoor plus the

surrounding town and parish councils. The meeting will be at RHS Rosemoor, 12 July, 10am. Cllr Steer is to attend, and will give an information update at the next meeting.

Cllr Huxtable attended the last Hall committee meeting, £6,231 is held at present with £4,800 put aside for legal fees to purchase the field. The DAAT paperwork is complete, the Beacon is being repaired and a new site has to be decided.
